General Range Information

As a reminder, this is a cooperative club. It takes everyone's help to take care of the ranges. All ranges are now stocked with supplies/tools to fix and replace target backboards in every house. If you see issues with the target backboard(s), please fix it/them.

Taking trash out of the range houses is also a member responsibility. There are dumpsters located at each range. It only takes a few minutes to clean up and if you see the trash can getting full, please empty it.

There is no dedicated staff to take care of these two tasks. Only you can make your club better.

If there are problems with buildings, locks or fences please let the range chairman or a club officer know.

General Lock and Combination Information

It has been noticed that some members have been opening the combination locks at the ranges for entry and only changing one of the tumblers to lock the gate back up. This is not a safe practice as anyone can come up and look at the lock and over time could easily put together what our combination is. We have already had a case of vandalism at the Sanford range this year. Please help out and roll all of the lock tumblers to a random number when you're done. Thanks...

Range Safety:

This is everyone's responsibility from gun safety to alcohol consumption at the range.

There has been more damage found at one of the ranges from a negligent discharge of a firearm and small alcohol containers (nips) found. Both are unacceptable and need to stop happening and only you can make this happen. If you see problems or safety issues talk to the individual. If that does not work, contact a club officer or chairperson and provide their badge # or license plate number for further action by the club.

Sanford Range:

Plate Racks are starting to get damaged. They are being shot at with a heavy cal. they aren't designed for. Every plate has been damaged/dented out on the backside. They are getting trashed and not getting fixed. The other plate rack it laying on its side by the berm, because Bruce tried to move it by himself, and it fell off his truck. It will stay there until someone helps him move it (they are extremely heavy).

Will check to see how much to replace the plates (3/8" AR500). Should also post "Limits" for what can be shot at the plates.

If you see someone shooting with what they are not supposed to at the plates, PLEASE get a Badge #, ask to see their Membership card for their name, get their License Plate # & vehicle description, or take pictures with your phone.

Remember this is your club. Your dues may pay for what we have but without you or someone else to volunteer and clean up after you it is not going to be done. Be proud of what we have and take care of it.

We are a volunteer club, with out you and your help there is no club.

BERWICK RANGE

If you see a target board that needs to be replaced, replace it. It's only a couple of screws. If the trash can needs to be emptied, then take it over to the dumpster and empty it.

Please do not put targets on 2x4s or upright posts. These are the frames that hold the target boards and cost a lot more to replace. Do your part and remind your friends and others if they forget.

We have one of the finest shooting facilities in New England. It will only stay that way if everyone pitches in and helps.

Safety:

Safety courses for 2017 have been listed on the Maine State website at (<http://www.maine.gov/ifw/education/safety/index.htm>). The hunting and archery for York county are listed on **page 7**. See the Maine State website for other counties.

DO NOT post any targets on the 4x4 posts or the 2x4s that hold the backboards.

Place your targets on the backboards and away from the 4x4 posts and 2x4s. We spend a lot of money on lumber every year so that you can have backboards to tack your targets onto. There is no need for the damage that is being done to these frame works by bullets.

DO NOT shoot at rocks. Your bullets will not stay in the range if you hit the rock. Remember, your bullets must impact into the berm after going through your target. Please, think safety at all times while at the ranges. One mistake could close the range, or worse cost someone their life.

Safety first, fun second.

PLEASE SHOOT ONLY AT PROPER TARGETS WITH A BERM BEHIND YOUR TARGETS.

Tired of seeing this notice from the old newsletter, then help out and remind those around you that have forgotten.

Legislative Report:

The 128th Maine legislature has had a flurry of firearms related bills, and bills that came about due to firearms related issues. Many were passed, some were not – but today we stand with more freedoms than we did last year at this time.

LD9 – An Act to prohibit the creation of a Firearms Owner Registry – This came about due to concerns with Question 3 on last year’s ballot – the only way that universal background checks were possible was with a registry, knowing where each and every gun currently held was. This law prevents that possibility from occurring.

LD343 – An Act to Prohibit the Discharge of a Firearm within 300 Feet of a State owned Boat Launching Ramp – In regards to a state owned boat ramp, IF it is prominently posted, you can not discharge a firearm within 300 feet of the ramp. Basically, no duck hunting within 300 feet of a posted state owned ramp.

LD350 – An Act to repeal certain requirements concerning the sale and purchase of firearms – This bill requires that an FFL must show the 4473 when requested to a Law Enforcement Officer IF that individual has presented a WRITTEN notice that the inspection of that specific form pertains to an open/active criminal investigation.

LD693 - An Act To Clarify the Laws Governing Hunting from a Vehicle – Complicated, but allows loaded guns to be leaned against vehicles that aren’t running, allows target shooting from the bed or roof of a vehicle, allows hunting from an ATV or snowmobile that isn’t running, allows duck hunting from a motorboat that isn’t running. Basically if the motor is off, and you aren’t “inside” the vehicle, you are now legal to have a loaded long gun and fire it.

Legislative Report continued:

Non-firearms bills

LD1323 - An Act To Amend the Direct Initiative Signature Gathering Process – Due to some less than reputable Public Notaries over the last election cycle, this bill authorizes the Secretary of State to suspend, revoke or refuse to renew the commission of a notary public who has allowed another person to use that notary public's commission. It also authorizes the Secretary of State to invalidate a petition for a direct initiative or people's veto if the Secretary of State is unable to verify the notarization of that petition. The bill directs the Secretary of State to establish an online reporting system for suspected fraudulent signature gathering practices for direct initiative and people's veto petitions.

LD31 - Proposing an Amendment to the Constitution of Maine To Require That Signatures on a Direct Initiative of Legislation Come from Each Congressional District - This resolution proposes to amend the Constitution of Maine to require that the signatures on a petition to directly initiate legislation be of voters from each of the State's 2 congressional districts and that the number of signatures from each congressional district be not less than 10% of the total vote for Governor cast in that congressional district in the previous gubernatorial election. This resolution provides that, if the required votes are cast in favor of the proposed amendment to the Constitution, the proposed amendment becomes part of the Constitution on March 1, 2018 instead of on the date of the Governor's proclamation.

Here is what did not pass:

LD 351 – An Act To Allow Municipalities To Prohibit Weapons at Municipal Public Proceedings and Voting Places – There was no timeframe placed on this – if our club house was a “voting place”, then legally the town could have refused to allow us to have guns in the club house all year long.

LD 352 – An Act To Require a Dealer To Sell a Gun Lock with Every New Firearm – “Sell” being the primary word.

LD 443 – An Act To Allow Municipally Funded Hospitals To Prohibit the Presence of Firearms on Their Property

LD 501 – An Act To Increase Firearm Safety (Before purchase of a firearm, but present proof of a safety course)

LD 1154 – An Act To Provide a Voluntary Method of Determining Whether a Purchaser of a Firearm Is Prohibited from Possessing a Firearm without a Background Check

LD 1175 – An Act To Expand Options for the Prevention of Domestic Violence
